

## PLAYING RIGHTS

Members may find it more economical to purchase Playing Rights from Adelaide Shores Golf Park through the Club Secretary. The costs of these are detailed below.

### CLUB COMPETITIONS

Playing Competition Golf is part of the assessment for obtaining Playing Rights.

## GENERAL INFORMATION

Entrance and Club Fees are payable within 14 days from receipt of written advice of Membership acceptance. A Members Handbook, which outlines the Competition Programme and the conditions that apply will be issued upon payment of the fees.

The Westward Ho Golf Club Inc. is a Private Club which was formed in 1957. Its modern Club Rooms are located at the entrance to The Adelaide Shores Golf Park at West Beach, South Australia.

The Club has two Courses available to Members and which are maintained and administered by Adelaide Shores on behalf of the West Beach Trust. The courses form an integral part of the Adelaide Shores Tourist Park providing accommodation, boat haven, sports fields and other leisure & recreation areas.

The Club, being only 10Km's from the City Centre, is easily accessed from suburban Adelaide. The Courses are only slightly undulating links style which offer all golfers a challenge without the exhaustion experienced at many other local but hilly courses.

The Club plays all of its Competitions on either of the two courses within the Golf Park. The Executive 60 Course is a Par 60 and the Patawalonga Course is a challenging Par 72. Men's and Women's and Pennant Competitions are available for all standards of golfers.
